## WATER RATE REMINDER

At the regular meeting of the Board of Directors of Quail Valley Water District held August 23, 2025, the Board approved the next scheduled rate increase of 10% to be effective with your January water bill. This will bring the monthly meter fee to \$162.58 for a standard residential 5/8 X 3/4 meter. Consumption charges for the first 12 units (1 Unit = 748 Gallons) will increase to \$10.45 per unit. Tier 2 consumption (13 Units to 24 Units) will increase to \$12.53 per Unit while Tier 3 (25 Units to 36 Units) will be \$18.80 per Unit. Tier 4 usage (all usage over 24 Units) increases to \$41.78. While no one likes rate increases, this increase is necessary to cover the inflationary cost increases the District is experiencing.

### PLEASE CONSERVE WATER

On Christmas Eve, the distribution system experienced a catastrophic failure resulting in the loss of approximately 45,000 gallons of water over a four-hour period. The failure was in a four-inch main at the upper end of the distribution system near the water treatment plant. Staff responded and found the leak area and isolated the leaking line to prevent any further water loss and no customers lost water service but we are now faced with bringing the tank levels back to normal without overstressing the well. It is anticipated that it will take a couple of weeks of adding about a foot of water to each tank per day while also supplying our normal demand. To help us fill the tanks and prevent depleting our water source, please conserve water wherever possible. Please do not leave water running unnecessarily and repair any leaks promptly. Your assistance is greatly appreciated!
